Update on the Biennial Scientific Conference on medicines regulation in Africa, 2-3 December 2013, Johannesburg South Africa

The first biennial scientific conference which will take place from 2 to 3 December 2013 in Johannesburg South Africa is fast approaching.

This conference, the first of its kind in Africa, is set to provide a forum to share scientific advances and current best practices in regulatory science disciplines amongst policy makers, regulators, industry and scientists. It will also provide an opportunity for stakeholders to review current global developments in the regulatory environment and assess their impact on the commercialization of health research products as part of implementation of the African Union Pharmaceutical Manufacturing Plan for Africa (PMPA).

Progress on the draft Model Law

Following the review of the Draft Model Law on Medicines Regulations which took place during the meeting of the Technical Working Group on Medicines Policy and Regulatory Reform in Nairobi earlier this year (June 2013), a sub-committee working on the finalization of the model law was convened in Durban from 12-16 August 2013. The model law was revised in consideration of comments from stakeholders and the incorporation of WHO guidelines.

The revised model law from the TWG-PRR Subcommittee on the finalization of the Model law is to be presented to the Pan African Parliament Committee on Health Labour and Social Affaires and the Regional Caucuses on the 20th October 2013. This will be by regional and national consultations with governments, legal experts, NMRAs and Parliamentarians from all AU Member states beginning early 2014.

Call for Expression of Interest for inclusion to the Regional Centres of Regulatory Excellence (RCOREs) in Africa!

As part of its mandate to strengthen regulatory capacity development, the AMRH Programme is in the process of establishing Regional Centres of Regulatory Excellence (RCOREs). The NEPAD Agency AMRH Programme is therefore pleased to announce a Call for Expressions of Interest for eligible institutions to submit applications for consideration to be a Regional Centre of Regulatory Excellence in Africa.

The selection process for RCOREs will follow the following steps:

- Application: Call for bids and submission of expression of interest
- Assessment: Assessment of expressions of interest, short-listing and audits
- Selection: shall be based on the eligibility criteria outlined above
- Performance Evaluation/Review: monitoring for continued performance

For United Republic of Tanzania, consultation meetings are to be held from 2-3 October in Tanzania-Zanzibar and 28-29 October, in Tanzania-Mainland.
